

# The City of Frostproof, Florida Request for Bids:

## Street Paving & Right of Way Improvement

The City of Frostproof will be accepting bids for street paving and right away improvements; sealed bids are due at 9:00 a.m. prevailing time on July 29, 2024.

### Resurfacing of the following streets

Paving Start Intersection	Paving End Intersection
Thompson Ave. and 9 <sup>th</sup> Street East	Thompson Ave and 11 <sup>th</sup> St
W. 8 <sup>th</sup> St and Scenic Hwy S	320' To the west of intersection
9 <sup>th</sup> St E and Scenic Hwy S	320' to the east of the intersection

### Right of way improvements/retention swales

The City will identify areas in the right of way inside the project areas. All swales will be constructed from edge of pavement to the private property line.

### Project Specifications

- . Roadways without curbing will be edged and swept before resurfacing.
- A.** All potholes shall be patched prior to resurfacing.
- B.** The contractor will arrange work so it will not interfere with the normal flow of traffic.
- C.** The contractor will include a double yellow line for 20' with a white stop bar at any intersection where there is a stop sign.
- D.** Contractor will arrange work schedule to accommodate schools and school crossings at times they are in use.
- E.** Apply tack coating to ensure proper bonding of all streets to be resurfaced.
- F.** Resurfacing will be done with a minimum 1 ¼ "finished product of type S-3 asphalt.

- G.** All manholes, Driveways and intersecting streets must be milled around at a distance of 24” to ensure smooth transition.
- H.** Manhole ring and water valve cover will be adjusted by contractor to meet grade.
- I.** All material from street sweeping/cleaning shall be removed from the job site.
- J.** The City will reserve the right to use any or all milling removed from city streets.
- K.** Retention swells will utilize the entire right of way in specified areas and are to be constructed at a 4 to 1 slope.
  
- L.** Retention swells shall be sodded leaving the bottom of the retention area sand.

The City of Frostproof is requesting sealed bids for resurfacing with patch work and right of way improvements throughout the city. Bids must be submitted to the City of Frostproof City Clerk’s office.

All bids must be submitted in sealed envelopes, no later than 9:00 a.m. prevailing time on July 29, 2024, addressed to the City of Frostproof and plainly marked on the outside Sealed Bid, 2024 Street resurfacing & Right of Way Improvements. It is the responsibility of the bidder to deliver his or her bid to the City Clerks office, 111 West First Street Frostproof, Florida 33843 on or before the specified date and time.

Bidders are hereby advised that this project is funded solely by the City of Frostproof. Federal Labor Standards Act will be followed, and the city is an Equal Opportunity Employer.

Bidders are also required to submit a completed Non-Collusion Affidavit of Prime Form and Sworn Statement on Public Entity Crimes Form with the sealed bid.

The City Reserves the right to reject any or all bids, to waive informalities, to re-advertise, and to accept the bid in the best interest of the City, not necessarily the lowest bid. The City also reserves the right to request any additional information after bids are received to determine bidder qualifications.
